

Freelance Affiliate Work Agreement

This Freelance Affiliate Work Agreement ("Agreement") is made and entered into as of the date of signing ("Effective Date") by and between:

1. Monasy Limited

A company incorporated in England and Wales, hereinafter referred to as "GoodByEmail."

2. []

The Freelancer, hereinafter referred to as the "Champion."

1. Overview

This Agreement governs the Champion's participation in GoodByEmail's affiliate program, also referred to as the "GoodByEmail LTD Champions Program." By signing this Agreement, the Champion agrees to abide by its terms and conditions.

2. Independent Contractor Relationship

The Champion is an independent contractor and not an employee, agent, partner, or representative of GoodByEmail. Nothing in this Agreement creates an employer-employee relationship, partnership, or joint venture between the parties. The Champion is solely responsible for their taxes, national insurance contributions, and compliance with all applicable laws in their jurisdiction.

3. Responsibilities of the Champion

The Champion agrees to:

1. Promote GoodByEmail in accordance with the terms of this Agreement.
 2. Comply with all applicable advertising, consumer protection, and data privacy laws, including disclosure of affiliate relationships in marketing materials (e.g., using hashtags such as #ad).
 3. Provide accurate and up-to-date contact and payment information.
 4. Avoid any behavior that is abusive, fraudulent, or misrepresentative in connection with the GoodByEmail Champions Program.

4. Commissions

1. Champions earn a 10% commission for each referred customer who purchases a GoodByEmail LTD plan.
 2. Commissions will be calculated on the actual payments received by GoodByEmail, excluding refunds and chargebacks.
 3. Payments will be made via PayPal within 30 days after the campaign ends, provided the total commission exceeds \$50 USD.

5. Referral Tracking

GoodByEmail will track referrals using cookies that last for 30 days. Commissions are attributed if the referral makes a purchase within this period.

6. Confidentiality

The Champion agrees to keep all confidential information obtained during participation in the program secure. This includes, but is not limited to, customer data, marketing strategies, financial details, and conversion rates.

7. Intellectual Property

GoodByEmail grants the Champion a non-exclusive, revocable license to use its branding, logos, and promotional materials solely for participation in the GoodByEmail Champions Program. Unauthorized use is strictly prohibited.

8. Termination

1. GoodByEmail may terminate this Agreement at any time with written notice.
 2. If terminated for cause (e.g., violation of rules), unpaid commissions are forfeited.
 3. If terminated without cause, the Champion will receive commissions earned up to the termination date.

9. Modifications to the Agreement

GoodByEmail reserves the right to update or modify this Agreement at any time. Changes will be communicated via email or by posting the updated Agreement on the program website. Continued participation in the program constitutes acceptance of the revised terms.

10. Dispute Resolution

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. Any disputes arising from this Agreement shall be resolved through arbitration in accordance with the rules of the London Court of International Arbitration (LCIA).

11. Data Protection

GoodByEmail complies with the General Data Protection Regulation (GDPR) and other applicable data protection laws. Champions must handle any personal data collected or processed as part of their participation in compliance with these laws.

12. Entire Agreement

This Agreement constitutes the entire agreement between the parties regarding its subject matter and supersedes all prior agreements or understandings.
